Applications are invited from Indian citizens as defined in Article 5 to 8 of the Constitution of India for filling up of the following posts of Assistant Engineer (Civil) and Junior Engineer (Civil) in Water Resources Department, Govt. of Assam under Regulation 3(f) of the Assam Public Service Commission (Limitations of Functions) Regulation, 1951.

(1) **Scale of Pay:** Rs. 30000/- to Rs. 1,10,000/- PM (PB-4) with Grade Pay of Rs.12,700/- PM Plus other allowances as per rules of the Govt.

(2) **Age:** The candidates should not be less than 21 years of age and not more than 38 years of age as on 01-01-2021.

The upper age limit is relaxable :-

(i) By 5 years for SC/ST candidates i.e. up to 43 years.

(ii) By 3 years for OBC/MOBC candidates i.e. up to 41 years as per Govt. Notification No. ABP. 6/2016/9 dated Dispur the 25th April 2018.

(iii) For Persons with Disability (PWD) by 10 years irrespective of SC/ST/OBC and General Category of candidate as per Govt. Notification No. ABP 144/95/121 dated Dispur the 28th October, 2015.

The age limit of the candidates will be calculated on the basis of the Matriculation /HSLC Admit Card/ HSLC Pass Certificate issued by a recognized Board/Council and no other document shall be accepted in lieu of the mentioned documents.

(3) **Qualification:** (i) B.E or equivalent degree in Civil Engineering obtained from any institute approved by the AICTE and recognized by the Government.

(ii) The Bachelor Degree in Civil Engineering must be a Regular Full Time Course. **Bachelor Degree in Civil Engineering obtained through Distance Mode of Education, by whatever name called, will not be accepted.**

(iii) Apart from English, the candidate should have adequate knowledge of at least 1(one) official language of the State of Assam (i.e. Assamese/Bengali/Bodo) except candidates belonging to Karbi Anglong Autonomous Council and Dima Hasao Autonomous Council.

(4) **ESSENTIAL CRITERIA :** The candidate must be a permanent resident of Assam. For proof of permanent residence, the candidate or his/her parents must be voter of Assam. The

voter ID card of the candidate or his/her parents will be treated as proof of permanent residence. (Attach self-attested valid supporting documents).

(1) **Scale of Pay:** Rs. 14,000/- to Rs. 60,500/- PM (PB-2) with Grade Pay of Rs.8,700/- PM Plus other allowances as per rules of the Govt.

(2) **Age:** The candidates should not be less than 18 years of age and not more than 38 years of age as on 01-01-2021.

The upper age limit is relaxable :-

(i) By 5 years for SC/ST candidates i.e. upto 43 years.

(ii) By 3 years for OBC/MOBC candidates i.e. upto 41 years as per Govt. Notification No. ABP. 6/2016/9 dated Dispur the 25th April 2018.

(iii) For Persons with Disability (PWD) by 10 years irrespective of SC/ST/OBC and General Category of candidate as per Govt. Notification No. ABP 144/95/121 dated Dispur the 28th October, 2015.

(3) **Qualification:** (i) A candidate must pass 3(three) years Diploma in Civil Engineering from any Institute recognized by AICTE.

(ii) The Diploma in Civil Engineering must be a Regular Full Time Course. **Diploma in Civil Engineering obtained through Distance Mode of Education, by whatever name called, will not be accepted.**

(iii) Apart from English, the candidate should have adequate knowledge of at least 1(one) official language of the State of Assam (i.e. Assamese/Bengali/Bodo) except candidates belonging to Karbi Anglong Autonomous Council and Dima Hasao Autonomous Council.

(4) **ESSENTIAL CRITERIA** : The candidate must be a permanent resident of Assam. For proof of permanent residence, the candidate or his/her parents must be voter of Assam. The voter ID card of the candidate or his/her parents will be treated as proof of permanent residence. (Attach self attested valid supporting documents).

HOW TO APPLY

Applicants are required to apply online through Water Resources Department's Govt. website i.e. www.waterresources.assam.gov.in . No other means/ mode of application will be accepted and the Applications received through other means will be summarily rejected.

Rest of the application procedure along with the date of filling up of online application will be announced shortly in www.waterresources.assam.gov.in .

Screening/ Shortlisting : Candidates will be shortlisted on the basis of merit as per academic performance.

Methodology of recruitment: Due to the current pandemic situation, a contactless process of selection purely based on academic performance from HSLC to Degree for the post of Assistant Engineer (Civil) and HSLC to Diploma for the post of Junior Engineer (Civil) will be followed.

Cadre	Methodology
Assistant Engineer	HSLC or equivalent-10% HSSLC or equivalent - 20% Degree in Civil Engineering -70% In case of the candidates who have completed the degree in Civil Engineering through lateral entry after completing Diploma in Civil Engineering, their 20% weightage shall be calculated on the basis of marks/percentage obtained in Diploma and not on the basis of marks obtained in HSSLC or equivalent, irrespective of whether they have passed HSSLC or equivalent examination or not.

Junior Engineer	HSLC or equivalent -20% Diploma in Civil Engineering-80% Additional qualifications other than Diploma course in Civil Engineering, shall carry no additional weightage.

EWS

EWS candidates must produce Income & Assets certificate of the family issued by the Officer not below the rank of Circle Officer as per provision of para 5 of Govt. OM no ABP 07/2019/4 dated 10/04/2019. Kindly refer to the Govt. OM No. ABP 07/2019/16 dated 31/12/2019.


NOTE
