❖ **Filling of Status Retention Form Submission:**

 - 2) If a candidate who has been allotted a seat DOES NOT WISH to participate in next/subsequent round(s) - **SHOULD FILL STATUS RETENTION FORM.**
 - 3) Filling of Status Retention Form is choice of candidate. Institutes/Colleges **SHOULD NOT FORCE** candidate to fill Status Retention Form
- ❖ If a candidate is not able to submit DD due to Bank Holiday, he /she may pay the fees by Cheque and replace the same on next Bank working day.
- ❖ As per Rule No.12 of NEET-UG-2021 Information Brochure, last prescribed date for cancellation of admission to MBBS/BDS course is 30/03/2022 upto 05.00 pm. Penalty as per Rule No. 14 will be applicable for the candidates, cancelling the admission to MBBS/BDS course after this prescribed date (i.e. 30/03/2022 after 05.00 pm)
